At the time of 10:00 a.m. which was the time established for hearing relative to the request for annexation of certain territories to be annexed to Rural Water District No. 3 as requested by petition filed by Mr. H. O. Morris, et al, attorney Jack Brand, representing the petitioners in the water district, appeared before the Board with prepared Resolution No. 72-33. There being no persons appearing at the hearing and no objections thereto and the Board finding that the Rural Water District No. 3 unanimously approved this annexation, it was moved by Mr. Ice that Resolution No. 72-33 be hereby adopted, seconded by Mr. Cragan, and carried unanimously.

Mr. Dave Taylor, representing Eastman Kodak Company; Lucille Allison, Clerk of the District Court; and Sue Neustifter, Register of Deeds Elect conferred with the Board relative to the purchase of microfilm equipment which will be required to install microfilming in the office of the Clerk of the District Court. Following due discussion of many aspects of microfilming county records, the Board requested Mr. Taylor to present a firm figure for the supplying of microfilming equipment for the office of the Clerk of the District Court with the intention being that processing of film would be accomplished using processor presently in place in the office of the Register of Deeds. The Board agreed that the possible purchase of this equipment would need to be delayed at least until the end of the month of December. Mr. Taylor was also requested to provide the Board with cost estimates, time required, etc., of microfilming those records presently in the vaults in book form of the offices of Clerk, Treasurer, County Court, District Court, and those records in the Register of Deeds office which have not been previously micro-filmed.

Mr. Mathia explained to the Board that under his supervision Mrs. Baldwin has been working chiefly in the area of registration during the past year. Mr. Mathia indicated that he now wishes to put Dorothy Baldwin in complete charge of registration and name her chief registration clerk at a salary of \$465 per month effective January 1, 1973.
