The Board considered the request from the Planning Council on Services for the Aging, Inc., for funds from Douglas County to be used as matching funds for a grant request from the State Department of Social Welfare under the Older Americans Act. Following due discussion of the request it was moved by Mr. Heck that in accordance with authority granted in Statute K.S.A. 19-212, that Douglas County provide the Planning Council on Services for the Aging, Inc., funds in the amount of \$2125 which will be the county's share of matching funds relative to a grant request in the amount of \$17,000. Further stipulations and part of the motion are:

- a. That the City of Lawrence provide funding in equal amount
- b. That all areas of Douglas County be served in so far as deemed practical and feasible by the sponsoring agency
- c. That the grant request be approved

Motion was seconded by Mr. Stoneback, and carried unanimously.
