Mr. Carrol Crossfield of the Lawrence Police Department and Mr. Ed Hutchison of the Miller-Johnson Productions appeared before the Board to request use of the 4-H Fairgrounds for a circus on May 25, 1973. Mr. Crossfield and Mr. Hutchison indicated to the Board that the Fraternal Order of Police is obligated to hold a circus in Lawrence at some location on that date. Following due discussion it was moved by Mr. Heck that the 4-H Fairgrounds be reserved on May 25, 1973 for a circus to be sponsored by the Fraternal Order of Police, Lawrence Lodge No. 2, with the understanding that the sponsor will meet all normal requirements for the sponsoring of such event at the Fairground seconded by Mr. Stoneback, and carried unanimously.
