Engineer Sanderson discussed with the Board the need for a road material pulverizer and an all purpose tractor with the capabilities for propelling such a piece of equipment. After due discussion it was moved by Mr. Heck that we accept the proposal of Capital Equipment Company of Topeka, Kansas to supply one T030 Seaman mixer at a cost of \$7,690 and one 1971 used John Deere 70-A wheel tractor at a cost of \$13,000, seconded by Mr. Cragan. Mr. Heck and Mr. Cragan voted yes on the motion, Mr. Stoneback being absent. It is understood that Capital Equipment Company will provide a 375 meter hour new equipment warranty with the above described tractor.

Mr. Cragan and Mr. Heck voting yes on the motion, Mr. Stoneback being absent.
