The Board considered the application for conditional use permit requested by J H & J Rock Company to operate a rock quarry on land owned by Elmer Zeeb three-fourths mile south of U.S. Highway No. 40 on Douglas County Road No. 1025. Following due discussion it was moved by Mr. Heck that the Board approve the recommendation of the Lawrence-Douglas County Planning Commission which was for the granting of the conditional use permit for a rock quarry requested by J.H & J Rock Company to be located on land owned by Elmer Zeeb on County Road No. 1025, three-fourth mile south of U.S. Highway No. 40 with the issuance of the permit being subject to the following:

1. All terms and premises as set out in the letter to the Lawrence-Douglas County Planning Commission dated March 14, 1973.
2. All conditions as required by Lawrence-Douglas County Planning Commission as set out in the minutes of the Planning Commission meeting of March 28, 1973.
3. That the quarry operator maintain County Road No. 1025 as set out in agreement dated April 16, 1973, between Jack Hurlburt, General Manager of J H & J Rock Company and Dean Sanderson, P.E., Director of Douglas County Public Works Department.

Motion was seconded by Mr. Cragan. Since a fifty percent (50%) protest petition had been received by the Planning Commission, it was determined that in accordance with K.S.A. 19-2907, 1972 Supplement, a unanimous decision by the County Commission would be required to approve the conditional use permit. Since Mr. Heck and Mr. Cragan voted affirmative and Mr. Stoneback voted negative, the request is being returned to the Planning Commission.
