Approved the minutes of the meeting of May 23, 1973.

The Board considered finalization of allocating revenue sharing funds for the first three entitlement periods. Following due discussion it was moved by Mr. Heck that revenue sharing funds for the first two entitlement periods in the amount of \$338,123 be allocated as follows:

- (1) Douglas County Judicial Law Enforcement Facility and Related Improvements \$320,000

Revenue Sharing Priority - Capital Improvements

Statutory Authority - K.S.A. 19-1569

- (2) County Wide Ambulance Service \$ 18,123

Revenue Sharing Priority - Health and/or Public Safety

Statutory Authority - K.S.A. 1972 Supp. 19-261 and 19-262

With investment interest to be allocated to the aforementioned facility or to priority maintenance and operation of county offices and departments.

Mr. Cragan seconded the motion. Mr. Heck and Mr. Cragan voted affirmative and Mr. Stoneback voted negative. Motion carried.

Revenue Sharing Priority - Recreation

Statutory Authority - K.S.A. 19-212

- (4) Council on Aging (Upon request and approval) \$ 7,500

Revenue Sharing Priority - Assistance to Aging

Statutory Authority - K.S.A. 19-212
