Whereas, the City of Lawrence, Kansas, did on the 5th day of June, 1973 file with the County of Douglas three separate petitions requesting the vacation of existing utility easements on each of the three separate tracts which are described as follows:

- (1) The South 10 feet of Lot 9, Block 2, India Addition, an Addition to the City of Lawrence, Kansas
- (2) The North 7.5 feet of the East 945.70 feet of Lot 1, Auto Plaza Subdivision, an Addition to the City of Lawrence, Kansas
- (3) The East 5 feet of Lots 5, 6, 7, 8, and the West 5 feet of Lots 1, 2, 3, 4, in Block 1, Westdale Addition No. 2 and replat of Lots 1, 3, 4, 10, 11, 12, 13, 14, and 15 Westdale Addition, an Addition to the City of Lawrence, Kansas

Whereas, notice of the hearing on the vacation of each of the three separate and distinct utility easements was duly and legally published in the Lawrence Daily Journal World in strict conformity with the laws of Kansas, the affidavit and proof of publication of each of the notices for hearing having been examined by this Board and approved.

Now therefore on this 20th day of June, 1973, at 10:00 a.m. there comes on for hearing the Petitions of the City of Lawrence, Kansas, for the vacation of the above described utility easements as noticed by said publication service. The petitioner appears by its attorney, Gerald L. Cooley, and there are no other appearances by person or counsel. The Commission finds that there has been filed no protest of any petitions at the time of this hearing or any time prior thereto. The Board further finds that the public will suffer no loss or inconvenience by said vacations, and that in justice to the petitioner the prayer of the petitioner in each of the said petitions should be and the same is hereby approved.

The Board finds that there shall be reserved to the City of Lawrence, Kansas, and all owners of lesser rights, for public utilities, rights-of-ways and easements for public service facilities, all such rights now in existence and use.

It is ordered by the Board that the County Clerk shall certify a copy of the order granting the vacation of each said easements to the Register of Deeds, Douglas County, Kansas, for recording as required by law.
