Darwin Rogers, County Assessor, informed the Board of the termination of Herman Tusher effective June 30, 1973. Mr. Roger's also requested the reclassification of Charlotte Shawver from Clerk to Real Estate Clerk and requested an increase in salary of \$45 per month relating to six-month length of service and reclassification bringing her salary to \$445 per month effective July 1, 1973. *Roads Bridge:  
Revision of  
policy relating  
to rights-of-  
way*

The Board discussed possible revision of policy relating to rights-of-way purchase for road and bridge purposes. After considerable discussion it was moved by Mr. Heck, seconded by Mr. Stoneback, and carried unanimously that the following policy be adopted: That rights-of-way for road and bridge purposes be acquired, if possible, by negotiation with landowner, with the intent being, to arrive at a fair market value for rights-of-way required. The fair market price negotiated on Non-FAS projects shall include fences and such other improvements that may be involved in the acquisition. Rights-of-way acquisition on projects involving federal-aid funds shall follow the procedures as set forth for Secondary projects by the Federal Highway Administration and Kansas State Highway Commission, and in compliance with Chapter 244, of 1972 Session Laws of Kansas. The Director of Public Works shall be responsible for the implementation and administration of the rights-of-way acquisition policy.

The Board received a proposal from architects Robertson-Peters-Williams relative to providing architectural services for the erecting of a Judicial-Law Enforcement Building for County and City government on a site designated by the County Commission. The proposal refers to Article 6 as follows: Schematic Design Phase - The architects agree to credit the owner (Douglas County) 33-1/3% of the fee for this phase (schematic design phase) for usable data for this phase from the design of Judicial and Law Enforcement Building, dated May 1970, and County-City Governmental Center, dated August 1971. This form is the standard form in all other respects. A letter in conjunction with the agreement specifies that the contract document phase of architectural services will be completed by April 1, 1974. The letter further states that a contemplated project completion date is on or before January 1, 1976. It was moved by Mr. Heck that the proposal be accepted, seconded by Mr. Stoneback, and carried unanimously.
