At 10:00 a.m. the Board was presented with sealed bids on the Branch of the Appanoose Creek Bridge project. Five bids were received. The low bidder was Bushman Construction Company, Box 364, St. Joseph, Missouri in the amount of \$34,476.80. Following review of all bids by Engineer Sanderson it was recommended by the Engineer to the Board that the low bid of Bushman Construction Company of St. Joseph, Missouri with a bid of \$34,476.80 be accepted. It was moved by Mr. Heck that inasmuch as the construction of this bridge is being participated in by both Douglas and Franklin County, that the Board accept the bid of Bushman Construction Company for the construction of the Branch of the Appanoose Creek Bridge at the bid price subject to concurrence by the Franklin County Commissioners, seconded by Mr. Stoneback, and carried unanimously.

Mr. Kyle Ward, representing Blue Cross-Blue Shield Insurance Company, appeared before the Board to discuss actual County experience with employees health insurance coverage for the period June 1, 1972 through May 31, 1973. Mr. Ward informed the Board that in addition to establishing the maximum group reserve during that year, that an amount of \$5,463.02 was being refunded to the Douglas County Health Insurance Program. Following due discussion it was moved by Mr. Heck that this refund be prorated relative to County and employees contributions and that refunds be made on an equitable basis to employees who have claimed dependent coverage, seconded by Mr. Stoneback, and carried unanimously.
