bond for
Quin T's Estates
Subdivision

Engineer Sanderson appeared before the Board with a copy of a letter to Mr. William T. Harris, Lawrence, Kansas pertaining to Quin T's Estates Subdivision performance bond. The performance bond to guarantee that construction of the roads in subject subdivision as set out by the Douglas County Public Works Department shall be \$9,000. The construction of said roads shall be completed within three years or after sale of 70 percent of the lots, whichever shall come first; the three year time period to begin with the approval of final plat. The performance bond may be reduced from time to time as roadways are constructed. Such reduction in security to be determined by the office of the County Public Works Director in accordance with Douglas County Subdivision
