Mr. Dick McClanathan, City-County Planning Director, presented to the Board Item No. 6 of the Lawrence-Douglas County Planning Commission minutes of July 25, 1973, which refers to the final plat of Rosemont Estates No. 2. This being a plat of approximately 19.64 acres, more or less, generally located one and one-half mile south of Kanwaka Corners and one-fourth mile west of Kanwaka Township Road No. 120 on 18th Street. Said subdivision is all in the SW $\frac{1}{4}$  of the NE $\frac{1}{4}$  of Section 2, Township 13 South, Range 18 East. Submitted by Charles F. Steinbacher, Engineer for William G. and Lois M. Hess. After considerable discussion it was moved by Mr. Heck that the Board accept the recommendation of the Planning Commission which was for the approval of the final plat of Rosemont Estates No. 2 subject to the first five conditions as follows:

1. That a temporary turn-around be shown on the plat
2. That the east-west portion of 18th Street be terminated at the approximate location of Lois Court, as shown on the preliminary plat, and another name be given to the north-south portion of the road that was originally shown as 18th Street
