*Agreement: Finney & Turnipseed for consulting engineering services for 51 county bridges*

Dean Sanderson, Public Works Director, appeared before the Board presenting a proposal of an agreement between Douglas County, Kansas and Finney & Turnipseed, consulting engineers, Topeka, Kansas, relative to preliminary surveys and preliminary construction cost estimates for certain specified bridges (fifty-one bridges). It was moved by Mr. Stoneback that the Board accept the proposal of Finney & Turnipseed relative to preliminary surveys and preliminary construction cost estimates for fifty-one specified bridges in Douglas County in the amount of \$22,500, seconded by Mr. Heck, and carried unanimously.

*Petition received for city for vacation of road right-of-way & real estate*

The Board noted receipt of Petition from the City of Lawrence requesting the setting of a date for a hearing in the matter of the vacation of the road right-of-way in and upon the following described real estate situated in Lawrence, Lawrence, Douglas County, Kansas, to-wit: beginning at the northwest corner of Lot 12, Block 1, South Hills, an Addition to the City of Lawrence; thence North 30 feet; thence East 610 feet to a point on the West line of Lot 17, in said Block 1, said point being 62 feet East and 30 feet North of the Northeast corner of Lot 16 in said Block 1; thence South 30 feet; thence West to the point of beginning. *Proposal received from Finney & Turnipseed for study of bridge over Kansas River*

Dean Sanderson, Public Works Director, presented the Board with proposal from Finney & Turnipseed with reference to the proposed study of a bridge over the Kansas River in the vicinity of Massachusetts Street. The Board will review the proposal and delay decision pending the receipt of supplemental for geology on the project.
