Attorney Jack Brand appeared before the Board with Petition for Attachment of Adjoining Lands to Admittance to Rural Water District No. 3 in Douglas County, Kansas. The Board finds that notice of hearing on said petition has been given as required, proof of publication has been received, and statements in petition are true, and that hearing on the petition was duly held on January 23, 1974, at 10:00 a.m. The boundaries of lands owned by the landowners are described as NW  $\frac{1}{4}$  of Section 24, NE  $\frac{1}{4}$  of Section 23, SW  $\frac{1}{4}$  of Section 13, and SE  $\frac{1}{4}$  of Section 14 all in Township 13, Range 18. The areas are without an adequate water supply at this time. The attachment to the water district will be conducive to and will promote the public health, convenience and welfare. Fifty percent of the landowners described above signed the petition for attachment. Mr. Brand appeared in behalf of Rural Water District No. 3, Walter G. Kampschroeder and I. C. Anderson. No persons appeared to object. It was moved by Mr. Heck that the Board adopt Resolution No. 74-6 which resolution approves the annexation of the above-mentioned territory to Rural Water District No. 3, seconded by Mr. Cragan and carried.
