Ernest Coleman, revenue sharing consultant, appeared before the Board to discuss proposed emergency request for Douglas County Revenue Sharing Funds to cover March 1 to June 30, 1974, operation of the Lawrence Indian Center Services. Following due discussion it was moved by Mr. Stoneback that the Board approve \$1,995 for the Lawrence Indian Center to be paid from revenue sharing funds, seconded by Mr. Heck, and carried unanimously. Of this amount, \$1,000 is Recreation and \$995 is Social Services.

The Board noted receipt of the minutes from the Bert Nash Community Mental Health Center, Inc., for the month of January 1974.

Al Skeet, Maintenance Supervisor, appeared before the Board to request the employment of Charles Newman on a temporary part-time basis at a salary of \$2.50 per hour, effective February 20, 1974, to be paid from the Park Fund. It was moved by Mr. Stoneback that this request be granted, seconded by Mr. Heck, and carried unanimously.
