Sheriff Rex Johnson appeared before the Board to discuss the sounding of the storm warning sirens. After due discussion it was moved by Mr. Heck that the Sheriff's Department will be responsible for sounding storm warning sirens for test purposes on the first Monday of each month at 12:00 noon, weather permitting. Should weather conditions be questionable for testing, the Sheriff's Department will counsel with the County Commission prior to final decision. The Civil Defense Director will be first responsible for sounding storm warning sirens in case of tornado warning. Should the Civil Defense Director not be available for any reason, then that responsibility shall become that of the Sheriff's Department. Amplifying the minutes of July 23, 1973, the term authentic sources shall be interpreted to mean weather wire and/or verified citizen observation. Motion was seconded by Mr. Stoneback and carried unanimously.
