Dean Sanderson, Public Works Director, appeared before the Board with quotes on two Hamilton blueprint files in the amount of \$195 each from M & M Office Supply. Mr. Sanderson informed the Board that this equipment was available only at M & M Office Supply. With this information that competitive bids for this desired compatible equipment were impossible to obtain, it was moved by Mr. Heck that the Board accept the quotes of M & M Office Supply to furnish two Hamilton blueprint files at a cost to the County of \$195 each, seconded by Mr. Stoneback, and carried unanimously.
