The project begins 4.5 miles north and 11 miles west of Baldwin and extends north approximately 2 miles. Design approval is being requested for grading, all weather surfacing and seeding for a rural two-lane facility. Maps, drawings, environmental statement and other pertinent information in support of the request for design approval are available for public inspection at the County Engineer's Office, Lawrence, Kansas.
