The Board noted receipt of the Lawrence-Douglas County Public Health Committee minutes dated May 15, 1974.

Treasurer Edythe Norman reported to the Board that she had on Friday, July 12, 1974, purchased \$70,000 of U.S. Treasury bills at a net cost of \$67,598.25 to yield 7.30% for the Judicial Building bond fund account.

It was moved by Mr. Heck that the Board hereby adopt Resolution No. 74-20 and that the Board order official publication notice on July 18, July 25, and August 1, 1974, and that a hearing on the aforesaid road vacation be set for August 12, 1974, at 10:00 a.m., seconded by Mr. Cragan, and carried unanimously.

The Board met with Leonard Barber and H. H. Belote representing Gold Cross Ambulance Service. Counselor Young was also present. The discussion concerned the necessity for increased rates and/or subsidy for the ambulance service. Following discussion Counselor Young was instructed to draft a revised contract and rate schedule which will reflect a general 20% increase in rates and a subsidy of \$250 per month. Agreement was reached that the County will pay cost for the annual audit completed as of February 28, 1974, that Gold Cross Ambulance will employ with approval of the Commission accounting and tax services furnishing monthly statements to the Commission, and further County agrees to install combination washer-dryer in the ambulance quarters.
