Following such discussion it was moved by Mr. Stoneback that pursuant to Chapter 94 of the Kansas Session Laws of 1972 this project be assigned to the Department of Public Works with costs of the project reimbursed by park fund, seconded by Mr. Heck, and carried unanimously.

Bicentennial:

Following discussion meeting with the City of Lawrence Commission and the Chairman of the Douglas County Bicentennial Committee, the Board further discussed possible allocation of funds to the bicentennial committee on this date. The Board agreed to indicate to the committee a consensus of the present Board that a sum of \$10,000 be placed in the 1976 budget. The Board further indicated that \$5,000 of this amount shall be earmarked for a bicentennial commemoration to be placed on the grounds of the new County judicial-law enforcement building with the balance being made available to the committee for development of county-wide commemoration. The Board would anticipate participation by the City of Lawrence in the commemorative project on the grounds of the judicial-law enforcement building. The Board noted that this indication of intent would need to be ratified by the 1975 Board of County Commissioners.
