request for the Conditional Use Permit. After being certain that all had been heard who wished to comment on this item, Mr. Stoneback moved that the Board approve the recommendation of the Lawrence-Douglas County Planning Commission which was to grant this Conditional Use Permit subject to the following requirements and stipulations as set out by the planning commission:

1. That the entrance from the quarry to the county road be constructed to the standards set by the County Engineer.
2. That the pond be located further to the northwest so all runoff coming from the stockpile area will drain into the pond.
3. That all regulations set by the Environment Protection Agency; State of Kansas, Department of Health & Environment; U. S. Mining Enforcement and Safety Commission; State Department of Agriculture, Water Resources Division be strictly adhered to.
4. That the reclamation plan proposed by the applicant be followed.
5. Prior to the alteration of the present physical condition of the land, a screening buffer of plant materials be placed along the northern border.
6. That a 100 foot setback be maintained along all boundaries and be shown on the plan of operation site plan presented by the applicant.
7. That the Conditional Use Permit and site plan be subject to review annually by the planning staff.
8. If any washing of rock is to be done, a second pond is to be located upstream from the first pond.

Motion was seconded by Mr. Whitenight and carried unanimously.

Ernest Coleman, revenue sharing consultant, and Judy Osburn appeared before the Board to discuss changes in position and adjustment of salaries relative to the grant of Douglas County Correctional Services and further related to the fact that Mr. Elery Phillips will be leaving his position as Director of Correctional Services. Following due discussion it was moved by Mr. Whitenight that Judy Osburn assume the position of Director of Douglas County Correctional Services and also retain the position of Counselor, at a salary of \$875 per month, effective April 1, 1975, which salary reflects a 7% cost-of-living increase, a 5% six month length of service salary increase, and the additional amount reflects additional duties as Director of Correctional Services, and that the salary of Deborah Mitchell, secretary, be adjusted to reflect a 7% cost-of-living increase and a 5% six month length of service increase bringing her salary to \$224 per month, effective April 1, 1975, seconded by Mr. Stoneback, and carried unanimously.
