Dick McClanathan, Lawrence-Douglas County Planning Director, appeared before the Board to present items which had come before the meeting of the Planning Commission on May 28, 1975. Mr. McClanathan presented item No. 7 which refers to the final plat of Quantrell Overlook No. 1 Subdivision. Following review and discussion of this final plat, it was moved by Mr. Stoneback that the Board accept the dedication of rights-of-way and utility easements as shown on the final plat subject to conditions as follows:

- (1) That the applicant's engineer file a letter with the Planning Office stating all lots have been pinned.
- (2) That a performance bond, in an appropriate amount be filed with the County Engineer to insure completion of required road improvements.

Motion was seconded by Mr. Whitenight and carried unanimously.

- (1) That the applicant's engineer file a letter with the Planning Department stating that all lots have been pinned.
- (2) That the applicant acquire permission from the State Highway Commission to place the entrance to Grove Lane in U.S. 59 right-of-way. This permission is to be acquired prior to commencement of road work. A copy of such is to be filed with the Planning Office.
- (3) That a performance bond in an appropriate amount set by the County Commission be filed with the County Engineer to insure completion of required road improvements.

Motion was seconded by Mr. Whitenight and carried unanimously.
