Roads Agreement*

Public Works Director Dean Sanderson presented the Board prepared Resolution No. 75-28 which resolution relates to confirming the provisions of an "Off-Systems" Roads agreement delegating authority to the State Highway Commission as agent for Douglas County (KSA 68-402b) and pertaining to the preparation and approval of plans, the acquisition of rights of way and the construction and maintenance of certain highway improvements in political subdivisions of the State. Following due discussion of the resolution it was moved by Mr. Stoneback that the Board adopt this resolution, seconded by Mr. Whitenight, and carried unanimously.

Public Works Director Sanderson then discussed with the Board an agreement delegating authority to the State Highway Commission as agent for Douglas County (KSA 68-402b) and pertaining to the preparation and approval of plans, the acquisition of rights of way and the construction and maintenance of certain highway improvements in political subdivisions of the state of Kansas. The agreement further indicates that a resolution confirming the provisions contained herein and authorizing delegation thereof has been duly adopted by the Board of Commissioners. It was moved by Mr. Whitenight that this agreement be approved, seconded by Mr. Stoneback, and carried unanimously.

The Board noted receipt from the State of Kansas, Department of Economic Development that a planning grant for FY 1976 in the amount of \$11,000 has been made available to Douglas County which must be matched by \$5,500 County funds. A resolution was requested from the County by the department which resolution would ascertain that the County funds would be made available upon request. It was agreed that such resolution would be prepared.

*New River Bridges:  
Public notice published  
by Coast  
Guard for permits  
no objections received*

The Board noted receipt of a communication from the Department of Transportation, United States Coast Guard, signed by Mr. S. W. Thoroughman, Chief of the Bridge Branch. The letter indicated that with reference to the public notice published by the Coast Guard with regard to the application for a permit to construct the two bridges across the Kansas River that the aforesaid notice has now expired and that no objections to the proposed work was received. The letter indicated however that several questions had been posed by the Kansas City District Corps of Engineers and The Bureau of Outdoor Recreation which questions require some clarifying answers. Engineer Sanderson indicated that our consultants Finney & Turnipseed could respond to the questions raised by the Corps of Engineers and the representatives of the City of Lawrence would be asked to respond to the questions posed by The Bureau of Outdoor Recreation.

No further business, the Board adjourned to meet on Wednesday, July 16, 1975.
