At the request of the Department of Secondary Roads, the Board reviewed their session minutes of June 16, 1975, at which time the proposal of Finney & Turnipseed, consulting engineers, to provide services for preliminary engineering and right-of-way incidentals on the Clinton Parkway project which would bring the project to the point of right-of-way acquisition was considered and accepted by the Board. The Board is aware that as of this date only \$235,000 of this proposal is to be funded, 70% by economic development program funds and 30% by local funds. Any expenditures in excess of the \$235,000 will be 100% funded by local funds, unless additional Federal funding becomes available prior to the conclusion of the aforementioned project.

Nancy Hartman, Director of Douglas County Drug Abuse Program, appeared before the Board with a communication from the executive committee of the Douglas County Drug Abuse Council recommending that the Board of County Commissioners request the acting director of the Drug Abuse Unit, Alcohol and Drug Abuse Section of Social and Rehabilitation Services, to implement the Douglas County Drug Abuse Council Planning Grant No. P2-05-4095 as of September 1, 1975, rather than August 1, 1975, and that the Board further request that the remaining funds in the current Grant No. P 04-74 be used for salaries to cover the new coordinator to be hired in August and to reimburse Nancy Hartman as a consultant on a part time basis during the month of August while she assists in orientation and training of the new planning coordinator. It was moved by Mr. Whitenight that the Board approve the recommendations of the executive committee of the Douglas County Drug Abuse Council and request the Drug Abuse Unit of the Alcohol and Drug Abuse Section of the Social and Rehabilitation Services to likewise approve these requests, seconded by Mr. Heck, and carried.
