*Clinton Lake:
Discussion on
lake development*

Representatives of the relocations branch of the U. S. Army Corps of Engineers, Mr. Donald Fritts and Mr. M. L. Johnson, along with the area supervisor of the Kansas Fish and Game Commission, Mr. Bob McWhorter, met with the Board to discuss mutual concerns relative to Clinton Lake development. Also present were assistants to Mr. McWhorter, Messrs. Finley, Bronoski, and Hunter, and Clinton Lake landowners Mrs. Martha Parker and Mrs. Lois Gaines. Discussion centered around the status of present and projected road projects and the necessity for close liaison between the Fish and Game Commission, Corps of Engineers, Clinton Township Board, and the Board of Commissioners in order to coordinate Clinton Lake access roads and bridges in a most efficient manner. The next scheduled meeting was set for November 10 at 10:00 a.m. with the following organizations to be represented: Clinton Township Board, U. S. Army Corps of Engineers, Kansas Fish and Game Commission, school districts concerned with Clinton Lake roads, and the Board of Commissioners.

Access point*

Discussion was held concerning the Lawrence Avenue access point on proposed Clinton Parkway with representatives of Kansas University and the University of Kansas Endowment Association. Also present were City of Lawrence Manager Buford Watson, Planning Director Dick McClanathan, County Engineer Dean Sanderson, and Consultant John Frazier. The ensuing discussion indicated there were several access point problems requiring further consideration. At the conclusion of discussion Planning Director McClanathan indicated his department would have available for a meeting on September 22, detailed analysis of proposed and projected Clinton Parkway access points for further consideration.

Ambulance Director Ted McFarlane presented to the Board financial reports of the Douglas County Ambulance Service thru September 3, 1975.
