Gary Miller, special projects engineer, presented the Board with a prepared agreement between Union Gas System of Independence, Kansas, and Douglas County relative to said company performing certain work and/or the occupancy of the County's highway right-of-way by their facilities in connection with the replacement of Bridge No. 11.77N-14.00E. The agreement sets out that the maximum cost to Douglas County for right-of-way of the company to be taken for the process of this improvement shall be \$861.35 with actual cost to be determined upon completion of the project. It was moved by Mr. Stoneback that this agreement be approved, seconded by Mr. Whitenight, and carried unanimously.

County Attorney Berkowitz accompanied by Mrs. Frances Kennedy, special investigator in his office, appeared before the Board to present the Board with a six-month report on check investigations. This report comes as a result of the employment as of April 1 of Mrs. Frances Kennedy as special check investigator under the Emergency Job Program. Darlene Hill, budget director, appeared before the Board with the information that the valuation of Douglas County which will be used for a final figure used in computing the County mill levy rate will be \$159,485,435 which is an increase of \$1,193,035 which was the projected valuation of July 1, 1975. Mrs. Hill indicated that this increase of valuation will lower the County mill levy rate from 20.29 to 20.13, a decrease of 0.16 mill.

The Board considered Douglas County-City of Lawrence joint resolution referred to as Douglas County Resolution No. 75-35 and City of Lawrence Resolution No. Grant city - County Rev. - (2) additional 4113. The Commission of the City of Lawrence adopted this resolution on October 7, 1975. The joint resolution relates to the need for two additional accesses to Clinton Parkway, and requests the Kansas Department of Transportation and the Federal Highway Administration to approve a request for such additional points of access. Following due discussion it was moved by Mr. Whitenight that Douglas County joint Resolution No. 75-35 be hereby adopted, seconded by Mr. Stoneback, and carried unanimously.
