The Board noted receipt of a letter from Engineer Sanderson relative to construction of roads in Quantrell Acres Subdivision. Engineer Sanderson reports to the Board that John Brown Road in the above referenced subdivision has been constructed and hard surfaced in accordance with Douglas County standards and the completion of this road satisfies the construction of streets in this subdivision. Engineer Sanderson indicates that the performance bond guaranteeing the construction is hereby released. Engineer Sanderson recommends that this road now be added to the Palmyra Township Road Mileage and further recommends that Douglas County offer Palmyra Township an intergovernmental maintenance agreement for this hard surfaced road as set out in Resolution No. 73-39. It was moved by Mr. Whitenight that the Board accept the recommendations of Engineer Sanderson, seconded by Mr. Stoneback, and carried unanimously.
