Following due discussion it was moved by Mr. Stoneback that the Board accept this quote for the aforementioned equipment, seconded by Mr. Whitenight, and carried unanimously.

Mr. Steele later presented the Board such a quote which indicated the regular price of such a machine at \$119.95 with a discount price being \$112 each for four of the above described mowers, which quote was submitted by Western Auto Association Store. Following further discussion it was moved by Mr. Stoneback that we accept the quote of Western Auto Association Store to supply these mowers, seconded by Mr. Whitenight, and carried unanimously.

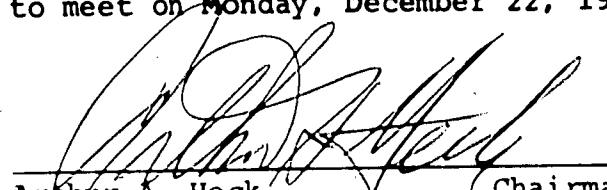
*Res. # HR-75-12-3;
