Counselor Young presented to the Board prepared Home Rule Resolution No. 76-2-1 which resolution amends the composition of the Douglas County Bicentennial Commission as originally set out in Resolution No. 75-7. This amended home rule resolution adds to the bicentennial commission one representative from the communities of Baldwin, Eudora, Lawrence, Clinton, and LeCompton. Following review and discussion it was moved by Mr. Stoneback that Home Rule Resolution No. 76-2-1 be herewith adopted to be in effect upon publication in the official County paper, seconded by Mr. Whitenight, and carried unanimously.

The Board then considered Resolution No. 76-11 prepared by Counselor Young which resolution provides for the appointment of one representative from each of the five bicentennial community organizations. Following due discussion and review of the resolution it was moved by Mr. Whitenight that Resolution No. 76-11 be adopted, seconded by Mr. Stoneback, and carried unanimously.

County Counselor Dan Young appeared before the Board and presented Resolution No. 76-12. During consideration of this resolution Board Chairman Mr. Heck absented himself from discussion or vote upon this matter. The resolution indicates that Douglas County shall maintain one active account with a bank in Douglas County which shall be rotated on an annual basis to each of the banks in Douglas County, Kansas. The affected banks in Douglas County and the sequence of rotation are as follows: First National Bank of Lawrence, Lawrence, Kansas; Douglas County State Bank, Lawrence, Kansas; University State Bank, Lawrence, Kansas; Kaw Valley State Bank, Eudora, Kansas; Baldwin State Bank, Baldwin City, Kansas; and Lawrence National Bank & Trust Company, Lawrence, Kansas. It was pointed out during the discussion of this resolution that the various banks of Douglas County have agreed to this scheduled rotation of one active account as set out in the resolution. After full discussion of the matter it was moved by Mr. Stoneback that Resolution No. 76-12 be adopted, seconded by Mr. Whitenight, and carried. Mr. Heck abstained.
