Walter Hicks, architect, along with Ernest Coleman, federal funds consultant, and Earl Van Meter, Douglas County Extension Director, appeared before the Board to discuss further the acceptance of the apparent low bid for the construction of the new extension building at the 4-H Fairgrounds. Mr. Hicks indicated that in a conference held with the apparent low bidder it seems to be positive and satisfactory in all respects. Mr. Hicks then recommended that the low bid of Harris Construction Company be accepted in the base bid amount of \$112,965 and that alternates 1 thru 6 be also included bringing the total construction price of Harris Construction Company to a total of \$153,392. It was moved by Mr. Stoneback that we accept Mr. Hicks recommendation, seconded by Mr. Whitenight, and carried unanimously.
