Engineer Sanderson reported to the Board his review of bids received for a motor grader which bids were received March 11, 1976. Engineer Sanderson reported to the Board that his recommendation was that we accept the bid of Martin Tractor Company to supply one Caterpillar, 130G Model, motor grader meeting all specifications as required at a net cost to Douglas County of \$41,468, which gives effect to a trade-in allowance for the machine being traded in the amount of \$17,856. Engineer Sanderson further indicated that this was the low bid relative to the articulation alternate. It was moved by Mr. Stoneback that this recommendation be approved, seconded by Mr. Whitenight, and carried unanimously.
