The Board noted receipt of a letter from Mr. Warren Barrand, auditor for Douglas County, which letter refers to an Internal Revenue Service assessment against the former Gold Cross Ambulance, Inc., whose assets and liabilities were assumed by Douglas County in December 1974. The assessment is for past due and unpaid federal payroll taxes for the months of August and September 1974. Mr. Barrand recommended to the Board that following his consideration of all facts in the case that Douglas County issue a check for the amount of taxes withheld by the employer in the amount of \$1,168.12. Following due discussion of the matter it was moved by Mr. Stoneback that we accept the recommendation of Mr. Barrand and remit check in the stated amount to Internal Revenue Service, seconded by Mr. Heck, and carried.

The Board noted receipt of information from the Kansas Department of Transportation relative to the following legal notice: Residents of Douglas County and other interested persons are hereby notified that Douglas County is requesting approval from the Kansas Department of Transportation of the design features for improving FAS Route 207 southwest of Lawrence. The project begins 0.5 mile south of Lawrence, 1.5 miles west of US-59 and extends west about 0.5 mile crossing Washington Creek. Design approval is requested for grading, a new bridge replacing an existing structure, all-weather surfacing and roadside seeding for a rural two-lane facility. Maps and other pertinent information in support of the request for design approval are available for public inspection at the County Engineer's Office, Lawrence, Kansas.
