The Board reviewed Application for Relief from a Tax Grievance relative to the following described property:

Beginning at a point 247 feet East of Northwest corner of the South-east Quarter of Section 5, Township 13 South, Range 20 East, Douglas County, Kansas, said point being on the North line of said Quarter Section; thence East on the North line of said Quarter Section 1320.5 feet; thence South 330 feet; thence West 650.45 feet; thence North 95 feet; thence West 670.05 feet; thence North 235 feet, more or less, to the point of beginning, in the City of Lawrence, in Douglas County, Kansas.

This is the property recently purchased as an addition to the Douglas County Fairgrounds. Following such review it was moved by Mr. Stoneback that this application be forwarded to the Board of Tax Appeals to the State of Kansas, seconded by Mr. Whitenight, and carried unanimously.
