Engineer Sanderson discussed with the Board the apparent necessity of replacing with expediency Bridge No. 16.30N-02.00E on County Road No. 1025 directly north of Stull. It was noted during the discussion that the present structure is very narrow and that its over-all condition was noted in the FAS bridge inspection report which inspection report recommended the replacement of this structure by or before 1977. It was further noted that traffic on Road No. 1025 would increase substantially with the development of Clinton Lake. Following due discussion it was moved by Mr. Whitenight that Engineer Sanderson be instructed to obtain consultants proposal for design and engineering services for replacement of Bridge No. 16.30N-02.00E, seconded by Mr. Stoneback, and carried unanimously.
