Tom McGee, Engineering Division Manager of the Public Works Department, presented the Board Resolution No. 76-32 which resolution establishes speed limit of 50 miles per hour on a section of road described as follows: Beginning at the East Quarter corner of Section 36, Township 13 South, Range 18 East, in Douglas County, Kansas, said point being on the center line of Federal Aid Secondary Route 213 and Phase I of Road Relocation I of the Clinton Lake Road Relocation Project; thence West on said center line approximately two and one-half miles to the West line of the Southeast Quarter of Section 34, Township 13 South, Range 18 East, and terminating at said point. Following review of the resolution it was moved by Mr. Stoneback that Resolution No. 76-32 be adopted, seconded by Mr. Whitenight, and carried unanimously.
