Mr. McFarlane presented to the Board an agreement between Douglas County and the University of Kansas Medical Center which agreement binds Douglas County to pay \$4,800 for training for four emergency mobile intensive care technicians in accordance with Douglas County's emergency medical system. The agreement includes covenants and obligations from the Kansas University Medical Center in relation to this specific training to be given to these indivi-
