Mr. Coleman then presented a Community Development Block Grant contract between the Board of County Commissioners of Douglas County and Historic Building Restoration Company for further work on the restoration of the Lane University building in Lecompton, Kansas. The amount of this contract is for \$9987. After discussion it was moved by Mr. Neis that we approve the contract as presented, seconded by Mrs. Bradley, and carried unanimously.

This authorization allows the Secretary of Transportation to proceed on this referenced project in accordance with provisions of an agreement dated July 24, 1975. After full discussion it was moved by Mr. Neis that this agreement be executed, seconded by Mrs. Bradley, and carried unanimously.
