in court program

Susan Zuther, Director of the Volunteers in Court Program, appeared before the Board to present a request for a submission to GCCA on a continuance basis of sub-grant No. 76-A2921-4-A which is a grant to fund the volunteers in court program from 1 July 1977 to 30 June 1978. The total amount of the request is \$25,887 with the contribution to be made from Douglas County in the amount of \$14,962 as our locally generated matching funds. After lengthy discussion and review of this application it was moved by Mrs. Bradley that we approve the application of the sub-grant and submit to GCCA for their review, seconded by Mr. Neis, and carried unanimously.

Joe Thibodeau, assistant manger of the Douglas County Ambulance Service, appeared before the Board to present four items of business. First, he presented the financial review of the ambulance service for the month of January 1977 of which the Board notes receipt.

Secondly, he requested of the Board the purchase of additional uniforms for the ambulance service specifically 42 uniform shirts and 34 trousers at a net amount of \$775.28 which is including a 10% discount which is granted by the seller. It was recommended that this purchase be made from the Unitog Company of Kansas City, Missouri in an effort to maintain quality and color with the uniforms currently used by this department. After discussion on the request it was moved by Mr. Neis that this quote be accepted, seconded by Mrs. Bradley, and carried unanimously.

Third, Mr. Thibodeau presented a recommendation from Mr. McFarlane on the purchase of an ambulance to replace the 1969 Oldsmobile and after a brief discussion on this matter it was agreed by the Board that they would defer action on the matter until the written confirmation of the ten-year warranty was received from the Modular Ambulance Corporation at which time the Board would meet with Mr. McFarlane in relationship to the budget and at which time a firm decision would be reached.

Mr. Thibodeau then requested a six-month merit increase for Terry Leger at a rate of 3% which would increase his hourly rate from \$3.00 per hour to \$3.09 per hour effective March 1, 1977. After discussion on this matter it was moved by Mr. Neis that this request be approved, seconded by Mrs. Bradley, and carried unanimously.

Sheriff Johnson appeared before the Board with two requests for salary adjustments for his department. The first recommendation is that Kenneth Massey, who is a shift supervisor in the corrections area, be given a six-month raise effective as of 1st of March 1977, which would raise his salary from \$624 per month to \$703 per month. After discussion on this request it was moved by Mr. Neis that this recommendation be approved, seconded by Mrs. Bradley, and carried unanimously.

The sheriff's second recommendation was that Andrew Armbrister II, deputy in this department who is eligible for a two-year merit review, receive a salary increase from \$879 to a rate of \$975 per month commencing as of 1st of March 1977. After discussion it was moved by Mr. Neis that this recommendation be approved, seconded by Mrs. Bradley, and carried unanimously.

Bob Duver, Douglas County Noxious Weed Supervisor, appeared before the Board to present his recommendation on the purchase of chemicals for the noxious weed department based on the bids received on the 23rd of February 1977. The recommendation is that the bid of Pueblo Chemical & Supply for Pueblo brand chemicals at the following prices be accepted:

LV, 5 gallon, \$5.61 per gallon
Amine, 1 gallon, \$4.40 per gallon
Amine, 5 gallon, \$4.25 per gallon
Amine, 30 gallon, \$4.10 per gallon

in the total amount of \$19,690.

Additionally, Mr. Duver recommended the purchase of Coop chemicals from Jackson Farmers, Inc. for 2,4,5-T, 1 gallon, \$12.25 per gallon and 2,4,5-T, 5 gallon, at a rate of \$12.00 per gallon in the total bid amount of \$1,812. After discussion on the matter it was moved by Mrs. Bradley that the recommendation be approved, seconded by Mr. Neis, and carried unanimously.
