Earl Van Meter, Director of Douglas County Extension Service, appeared before the Board to present quotes on fire extinguishers which are needed for the extension building. Mr. Van Meter recommended to the Board the low quote of American Fire Equipment Company of Salina, Kansas, for the purchase of three No. 424, 5 lb. ABC all purpose dry chemical fire extinguishers in the total amount of \$59.22 and one No. 322, 5 lb. American Alumiglo CO2 fire extinguisher for \$38.20. The total amount of this purchase is \$97.42, f.o.b., Salina. Mr. Van Meter indicated that he would personally pick these up from the supplier in Salina. After discussion it was moved by Mrs. Bradley that this recommendation be approved, seconded by Mr. Neis and carried unanimously.

The Board noted receipt of a public notice of pending Kansas River pollution control permit and authorization to discharge under the national pollutant discharge elimination system. This letter comes from the Division of Environment, State of Kansas Department of Health and Environment, Water Pollution Control division. It is listed as Public Notice KS-77-16/17 and is dated February 23, 1977, and indicates that comments pertinent to two developments which are taking place should be directed to Jean Herrold, Clerk; Permit Program, on or before the 23rd of March 1977. These comments should relate to the applications which have been made to the Division of Environment for discharge of sewage treatment by the City of Lawrence into the Kansas River and by the Timber Creek East Benefit District into the Kansas River via Elbow Creek. A copy of this public notice will be maintained on file in the commission office.
