The Board noted receipt of Order No. 9 from the District Court Administration of the Seventh Judicial District which comprises Douglas County. This order was executed by Judge Frank R. Gray on March 18, 1977, and indicates that the administrative judge has ordered a \$30 per month merit increase for the following to be effective April 1, 1977: Glenna Fraser, 6 month increase, from \$541 to \$571 per month; Wanda Kring, 6 month increase, from \$562 to \$592 per month; and Linda Diehl, 1 year increase, from \$588 to \$618 per month. It is recommended that this notice be published twice in the official paper of record on March 25 and April 1, 1977, with sealed bids to be received at the office of the Board of County Commissioners in the courthouse until 10:00 a.m., Wednesday, April 6, 1977, and at that time publicly opened. Ernest Coleman, federal funds consultant, presented the Board a determination from the Kansas Department of Human Resources, Division of Employment, which indicates that Mr. David Kendall, who had been previously enrolled as an employee of Douglas County funded by CETA Title VI funds, is declared to be ineligible for those funds. After a brief review and discussion it was moved by Mrs. Bradley that we accept this determination of ineligibility and revoke the appointment of Mr. Kendall to this CETA Title VI funded position as of February 1, 1977. Doug McEnery who is the new director of the Douglas County Court Diversion Program appeared before the Board to report that he had replaced Alan Johnson in the position of director of this program as of March 1, 1977. Mr. McEnery requested of the Board permission to advertise the position of part-time counselor to fill the position which was vacated when he moved up to the director's position. This position is to be advertised and notices given in accordance with county standard policies. It was requested by Mr. McEnery that the advertisement appear for a period of five days beginning March 24, 1977. Vacate alley 5th
& 6th Streets in
Eudora

Robert D. Kroeker appeared before the Board on behalf of Charles D. Stough, attorney for the City of Eudora, regarding the petition for vacation of a portion of the alley between Elm and Locust Streets in Block 172, between 5th and 6th Streets, in the City of Eudora, Douglas County, Kansas. The Board examined petition which was filed on February 28, 1977 pursuant to the authority of K.S.A. 12-504. The Board finds that notice appearing on said petition was given as provided by law. The Board found that no private rights will be damaged by such vacation; that no written objection to said petition has been filed; and that the public will suffer no loss or inconveniences by said vacation. The Board considered and unanimously ordered that that portion of the alley between Elm and Locust Streets in Block 172, between 5th and 6th Streets, in the City of Eudora, Douglas County, Kansas, and the owners
