After review of this recommendation it was moved by Mr. Neis that the sheriff's recommendation be approved, seconded by Mrs. Bradley, and carried unanimously.

Rural Water app. #5 At the advertised hour of 10:00 a.m. on the 31st of March 1977, Mr. Dean Burkhead, attorney for the Board of Directors of Rural Water District No. 5, Douglas County, Kansas, appeared before the Board as their representative at a public hearing to determine whether or not an order for attachment of adjoining lands to Rural Water District No. 5, Douglas County, Kansas, should be approved. Mr. Burkhead presented to the Board a copy of the petition for attachment of adjoining lands to Rural Water District No. 5, which lists in detail eight tracts specifically described therein to be attached to said water district. The petition in addition to the legal description of the particular properties makes the following findings:

1. That Rural Water District No. 5 of Douglas County, Kansas, is a corporate body in existence and the name of the water district to which attachment is desired.

2. That such lands as described are without adequate water supply and can be economically served by the facilities of said district.

3. That the attachment to said district will be conducive to and will promote the public health, convenience and welfare.

In accordance with the petition which was filed on the 15th of March 1977, this public hearing is being held.

Mr. Burkhead then presented an affidavit in proof of publication of this petition which was published in the Lawrence Daily Journal-World for one day on 23rd March 1977. In addition, Mr. Burkhead placed before the Board proof of mailing of notice and petition on attachment of adjoining lands to Rural Water District No. 5, Douglas County, Kansas, which is an affidavit from the county clerk which indicates a copy of this petition has been mailed to each of the petitioners of Rural Water District No. 5 and to the Chief Engineer of the Division of Water Resources, State Board of Agriculture, Topeka, Kansas, and to the Board of Directors of Rural Water District No. 5. No one appeared to protest either in person or in writing to this matter at this time. Mr. Burkhead then presented to the Board an order for attachment of adjoining lands to Rural Water District No. 5, Douglas County, Kansas, which indicates specifically within the document that the Board of County Commissioners of Douglas County, Kansas, being duly advised and hearing the statement of counsel makes the following findings:

1. That publication of the notice of this hearing was had in the Lawrence Journal-World on March 23, 1977, the same being more than seven (7) days before the date fixed for this hearing, and, further, that a copy of said petition and notice of this hearing was transmitted to the Chief Engineer, Division of Water Resources, State Board of Agriculture, and to each member of the Board of Directors of Rural Water District No. 5, Douglas County, Kansas, all as provided by K.S.A. 82a-615 and K.S.A. 82a-623.

2. That the statements contained in the petition are true.

3. That a majority of the members of the Board of Directors of Rural Water District No. 5, Douglas County, Kansas, do not object to such statement.

4. That the Board of County Commissioners, Douglas County, Kansas, shall enter into its minutes the findings of this hearing.

5. That the following-described tracts, described by metes and bounds, shall be attached to Rural Water District No. 5, Douglas County, Kansas, to-wit:

TRACT I:

Beginning at the Northwest corner of Section 27, Township 14 South, Range 19 East in Douglas County, Kansas, thence southerly 1320 feet, thence easterly 2640 feet, thence northerly 1320 feet, thence westerly along the north line of said section to the point of beginning, containing 80 acres, more or less.

TRACT II:

Beginning at a point 1320 feet south of the Northwest corner of Section 27, Township 14 South, Range 19 East in Douglas County, Kansas, on the west boundary of said section, thence easterly 3960 feet, thence southerly 1320 feet, thence westerly 3960 feet, thence northerly along the west line of said section to the point of beginning, containing 120 acres.

TRACT III:

All that part of the North 60 acres of the Northeast Quarter (NE $\frac{1}{4}$ ) of Section Twelve (12), Township Fourteen (14), Range Eighteen (18) East of the 6th P.M., lying East of County Road Number 421, in Douglas County, Kansas, containing 6 acres, more or less.

TRACT IV:

Beginning at a point 2640 feet west of the Southeast corner of Section 13, Township 15 South, Range 17 East in Douglas County, Kansas, on the south boundary of said section, thence northerly 1320 feet, thence westerly 1320 feet, thence southerly 1320 feet, thence easterly along the south line of said section 1320 feet to the point of beginning, containing 40 acres, more or less.
