1. In the area of Administrative Services, the projected number of minority female employees is decreased in that area of the timetable and increased in other areas. However, no involuntary terminations are planned or anticipated. Vacancies created by normal attrition will be filled by the most qualified applicants.

2. The chairperson of the Board of Commissioners assisted by the other two commissioners has the responsibility for the implementation of the Douglas County Affirmative Action Program.

The Board met in executive session with County Attorney Mike Malone and his investigator Mr. Jim Huskey to discuss a matter of concern to the Board relating to personnel. After the discussion it was moved by Mr. Neis that the Board meet with the particular employee involved and with County Attorney Malone at 11:00 a.m. on Wednesday, 6 July 1977 to further discuss this matter in executive session, seconded by Mrs. Bradley, and carried unanimously.

This letter indicates that the job of installation of the plantings by Suburban Lawn & Garden were inspected by a representative of that firm, Mr. Van Meter, and Jim Nighswonger in company with Darrell Abel and the project was found to be in good condition. The letter indicates a schedule of replacement for certain plantings which were lost during the first Spring.
