The Board considered a recommendation from Judith Osburn, Director of Court Services, which requests a salary increase in the amount of \$53 per month for both Linda Allen and Emily Lee who are probation officers. It is noted that this recommendation is approved by Sherlyn Sampson, chief clerk of the unified court system and Judge Frank R. Gray, administrative judge. After a complete review it was moved by Mrs. Bradley that these salaries as requested be approved, seconded by Mr. Neis, and carried unanimously.

The Board noted receipt of a correspondence from the Mayor of the City of Lawrence, Marnie Argersinger. The Board noted receipt of a notice from the Kansas Department of Transportation which indicates a public hearing has been scheduled for 17 August to consider the economic, social and environmental effects of the corridor and design proposed for improving 2nd Street, Iowa Street, and Lakeview Road in the City of Lawrence and Douglas County. This hearing will be held at the City Library Auditorium at 1:30 p.m. on the appointed day.

Tom McGee, engineering division manager, appeared before the Board to present a contract for right-of-way easement on Bridge Project 13.10N-17.00E between Perry Kitsmiller and Rosella M. Kitsmiller, husband and wife, and the Board of County Commissioners of Douglas County for a lump sum amount of \$388. This figure is based on approximately 0.21 acres of right-of-way easement and approximately 14 rods of barb wire fence and 14 rods of woven wire fence. The lump sum payment includes allowance for approximately 0.09 acres of planted wheat crop. After review of this contract it was moved by Mr. Neis that this contract be approved, seconded by Mrs. Bradley, and carried unanimously.

Tom McGee also presented a contract for right-of-way easement on Project No. 23-OS-452(1) between Samuel Neis, Jr. and Elizabeth Neis, husband and wife, and the Board of County Commissioners of Douglas County for a lump sum amount of \$1250. This figure is based on approximately 0.39 acres of right-of-way easement, 0.05 acres temporary easement for construction, 44 rods of barb fence, and 8 rods temporary fence. The lump sum payment includes allowance for additional corner posts required by the irregularity of the boundary (right-of-way line), the removal and erection of a new flood gate fencing, abstracting cost when property is sold and the permanent irregularity of the boundary of remaining tract. After review of this contract it was moved by Mr. Neis that this contract be approved, seconded by Mrs. Bradley, and carried unanimously.
