Street) from First Street to Second Street as shown on the Plat of Clinton, Kansas, recorded in the office of the Register of Deeds, Douglas County, Kansas.

After making these findings it was moved by Mr. Neis that, it being in the best interests of Douglas County, Kansas to vacate part of E. Street and the alleys in Block No. 38 as described in the townsite of Clinton, Kansas that it be resolved by this Board that those described alleys and street be hereby vacated. This resolution to be titled No. 77-27, motion seconded by Mrs. Bradley, and carried unanimously.

Tom McGee, engineering division manager, presented to the Board an application from United Telephone Co. of Kansas, Inc. requesting authority to construct a buried telephone cable in Douglas County across a road at a point approximately 800 feet north of the Southeast corner of Section 21, Township 14S, Range 20 B.
