Contracts for 4 Contracts for rehab projects Mr. Coleman presented to the Board four contracts for community development block grant rehab projects as follows: Project Nos. 202A for \$875, 242 for \$2208, 245 for \$2467, and 336 for \$1887. All four contracts are between the Colhun Construction Company of Lawrence, Kansas and the Board of Commissioners of Douglas County. All four of these contracts have been reviewed and approved by the housing rehabilitation committee. Mr. Coleman recommends their approval. After complete review it was moved by Mr. Neis that these four contracts as detailed be approved, seconded by Mrs. Bradley, and carried unanimously.
