Ruth Vervynck, treasurer elect, appeared before the Board with employment recommendations for the people who will be serving in the treasurer's office at the time her election becomes effective. First, Ms. Vervynck recommends a change in classification for Irene Alvarez from the position of clerk to the position of motor vehicle supervisor effective 11 October 1977 with her salary to increase from the present \$584 to \$695 per month.
