The Board met with County Counselor Dan Young to discuss the upcoming judicial tax sale. Co. to bid on property County in an effort to protect the interest of Douglas County taxpayers in receiving a reasonable value for these lots during the sale in an effort to redeem the outstanding taxes on these properties. The Board agreed with Counselor Young in this procedure and authority was granted. Ted McFarlane, director of the ambulance service, appeared before the Board to recommend the purchase of additional uniform items as required by his deambulance: app. partment as follows: Ten jackets at \$19.95 each, fifteen nylon shells at Purchase of add. \$9.95 each, and nine liners for jackets at \$7.95 each, all subject to a 10% discount. The net amount of this purchase order will be \$378.27. After review of Mr. McFarlane's request it was moved by Mr. Neis that it be approved, seconded by Mrs. Bradley, and carried unanimously. Tom McGee, engineering division supervisor, appeared before the Board with three utility agreements on Project No. Br. 07.50N-08.95E, Br. 09.00N-21.38E, Bridges-Co.: app. and Br. 11.40N-19.00E between Southwestern Bell Telephone Company and the Ulitity agreements Board of Commissioners of Douglas County which agreements relate to provisions of K.S.A. 17-1901 as to the necessity for movement of utility equipment and 07.50N-08.95E facilities which are located on county right-of-way. The agreements indicate 09,00N-21,38E that relocation of existing facilities which are currently located on private 11.40N-19.00E easement will be paid for by Douglas County and that those facilities within county right-of-way will be moved at utility company expense, and that the 5. W. Bell Till construction or alterations of the company's facilities shall be completed within 30 days after the county furnishes to the company the required information. After review of these agreements it was moved by Mr. Neis that these utility agreements be approved, seconded by Mrs. Bradley, and carried unanimously. Sheriff Rex Johnson appeared before the Board to request approval of a grant application to GCCA for the replacement and purchase of fifteen walkie-talkie GCCA: Opp, sets and related recharging equipment. The total amount of this application appl, to purchase is \$12,880 less a trade-in on presently held equipment of \$250 bringing a net 15 Wallsie-talleie amount to be \$11,367 to be paid by GCCA plus \$631.50 paid by the state and \$631.50 to be paid by the local government as matching funds. After discusset. sion with Sheriff Johnson for need of this equipment and the availability of our local match it was moved by Mr. Neis that this grant application be forwarded to GCCA for their consideration, seconded by Mrs. Bradley, and carried unanimously. The request from Mr. Williams is in the amount of \$493.02 and after review and discussion it was moved by Mr. Neis that this amount be approved and paid from revenue sharing funds, seconded by Mrs. Bradley, and carried unanimously.

Order 's for. strubs wall Mr. Williams then presented Change Order Number 2 on the General Construction Contract, GC-2, on the Douglas County Courthouse Remodeling Project which recommends the removal/replacement of concrete floors in Rooms 16, 19, and part of Room 15 in the southwest corner of the basement of the courthouse building. The add amount for this change order is \$1,058, which will bring the new contract sum including this change order to \$193,103. After complete discussion on the need for this change it was moved by Mr. Neis that the recommended change be accepted, seconded by Mrs. Bradley, and carried unanimous ly. This change order is to be funded by revenue sharing funds.

Mr. Williams then presented Change Order No. 3 on the General Construction Contract, GC-2, on the Douglas County Courthouse Remodeling Project which change order indicates an addition of seven Juniper shrubs for an add of \$242 and a deletion of an "L" shaped screen wall and changing the height of the other two screen walls to 5'-8" in lieu of 8' on the exterior wall of the southeast corner for a deduct on this deletion in the total of \$2,736.
