Administrative Judge of the Seventh Judicial District, Frank Gray, appeared before the Board to discuss some recommended salary increases within the unified court system. First it was recommended a salary increase for Judith Osburn, director of court services, from \$1094 per month to \$1187.50 per month effective 1 October 1977. Additionally, it is recommended that Carol Hess, secretary for Douglas County court services, salary be decreased from \$596 per month to \$298 per month based on a change from full time to half time. Judge Gray pointed out that the increase for Mrs. Osburn is an adjustment based primarily on the enhancement of her duties and also point out that this increase was envisioned in the grant application to GCCA and approved by that body. After review of these recommendations it was moved by Mrs. Bradley that they be approved, seconded by Mr. Neis, and carried unanimously.

Judge Gray then reviewed with the Board recommendations forwarded to the office by Sherlyn Sampson, chief clerk, for two employees in her office: Wanda Kring eligible for a one-year merit increase is recommended a \$40 per month increase which would raise her salary to \$632 per month effective 1 October 1977, and Glenna Fraser eligible for a one-year merit review is recommended for a \$40 per month increase which would raise her salary to \$611 per month. After review of these recommendations it was moved by Mrs. Bradley that they be approved, seconded by Mr. Neis, and carried unanimously.
