Doug McEnery, director of the court diversion program which functions through Headquarters, appeared before the Board to review the contents of a grant application to GCCA for the continuation of the Headquarters Court Diversion Program for the year 1977-78. The financial arrangements for this funding year would be that the federal government would carry 40% share of the total grant amount, the state 5%, and Douglas County 55%. The total amount proposed as the net project cost is \$7,954.33 of which amount \$3,181.73 would be paid by GCCA, \$397.72 paid by the State of Kansas, and \$4,374.88 would be paid by Douglas County from the commissioners matching fund line item. After a complete discussion on the merits of the program and its future, it was moved by Mrs. Bradley that this grant application be approved and forwarded to GCCA for review, seconded by Mr. Neis, and carried unanimously.

No further business, the Board adjourned to meet on Wednesday, October 5, 1977.

The Board having noted receipt of a commitment of funds from CETA Title VI, which supports in part positions existing within Douglas County at the present time, notes the following continuations of employment under CETA Title VI for the year commencing 1 October 1977 and extending to 30 September 1978 for the following employees: Marjorie Raess, Willie Phelps, Cathy McGinnis, and Betty Powers. Ernest Coleman, federal funds consultant, points out that Mr. Phelps will be eligible for a six-month increase next month and Ms. Raess is eligible for a six-month increase at this time and recommends to the Board that Mr. Phelps salary be increased from \$510 to \$536 per month commencing 1 November 1977, and that Ms. Raess salary be increased from the current rate of \$600 per month to \$630 per month effective 1 October 1977. After discussion on this recommendation it was moved by Mrs. Bradley that it be approved, seconded by Mr. Neis, and carried unanimously. Mr. Coleman notified the Board that Lauren C. Swindler terminated 19 August 1977 and Joanne G. Toczykowski terminated 30 September 1977. Both employees were employed under the CETA Title VI program.

Mr. Coleman then presented to the Board a recommendation for employment under CETA Title VI for Norma J.
