Bridge-Co.; Bids opened on Broj. 77-3; taken under advisement At the advertised hour of 10:00 a.m., the Board accepted bids on Douglas County bridge and grading contract for Consolidated Project No. 77-3. On the grading portions for the four bridges involved one bid was received in the amount of \$84,753.10. The engineer's estimate for these four bridges is \$75,314.30. Six bids were received for the construction of bridges involved, with the apparent low bidder being Midwest Construction Company of Holton, Kansas, in the net amount of \$188,652.30. The engineer's estimate on these four bridges is \$240,902. After review of these bids received it was recommended by Engineer Sanderson and Bob Thorn, of the consulting firm of Finney & Turningseed, that the bids be taken under advisement by the Board for verification of amounts and a legal recommendation from the County Counselor as to the handling of the grading bid which is substantially above the engineer's estimate. After review it was moved by Mr. Neis that this recommendation be accepted, seconded by Mrs. Bradley, and carried unanimously.
