"linton Lake! recreational areas their development The Board met with the following representatives of the Corps of Engineers: Ed Elkins, Gary McGinnis, Vic Counts, Tim Carey, Mike Ensch, and Carmeline Guinta. Also present were Roger Hedrick, Lawrence-Douglas County Planning Director; Fred DeVictor, Director of Parks & Recreation for the City of Law-rence; and interested citizens. The discussion related to the projected development of the recreational areas around Clinton Lake particularly Clinton State Park and Bloomington. Those areas are the ones in which the principal recreational areas will take place and the Board was interested in the nature and extent of this development as to its potential effect as to the commercial and residential zoning which may be necessitated in the Clinton Reservoir area. The Board indicated its desire to the representatives of the Corps to be involved in this planning process as it goes forward from this time. Mr. Elkins of the Kansas City District Office indicated that the Corps would forward a letter to this Board which would indicate its intent to review future plans by way of commercial or recreational development within these Corps controlled recreational areas.

In addition, the Board discussed with the Corps representatives the blasting being done in removing the old bridges from the reservoir area. It was strongly requested by this Board that the intensity of this blasting be reduced, that the size of the charges used be substantially limited and that they be fired sequentially rather than simultaneously in order to limit the impact, that any smaller bridges in more dense residential areas be removed by machinery rather than blasting where possible, and finally, that better communications be provided to the community as to the projected time of specific blasting so that the neighborhood involved could be forewarned. The Corps representatives agreed to pursue these recommendations in an effort to minimize damage and concern amongst the citizens who are being affected by this blasting process.

The Board noted receipt from the Kansas State Board of Agriculture, division of water resources, of a permit for a proposed channel change and bridge construction project along Spring Creek at a location in the Southeast Quarter (SE¹₄) of Section 23, and the Southwest Quarter (SW¹₄) of Section 24, both in Township 13 South, Range 20 East, Douglas County, Kansas.

No further business, the Board adjourned to meet on Wednesday, November 2, 1977.

records consultant for Valleyview with the services to be rendered three hour per quarter at the rate of \$15 per hour plus travel expenses. After review it was moved by Mrs. Bradley that this consultant contract be approved, seconded by Mr. Neis, and carried unanimously.

Ms. Smith recommended the hiring of Mary Beth Kemper to fill the position of part-time kitchen assistant having begun work on 22 October 1977 at a suggested starting salary of \$2.35 per hour. This employee is to replace a part-time employee who is on a temporary leave-of-absence. After discussion it was moved by Mrs. Bradley that this recommendation be approved, seconded by Mr. Neis, and carried unanimously.

Ms. Smith recommended a six-month merit salary increase for Lawrence Curry, janitor at the Valleyview home, from the current rate of \$2.40 per hour to \$2.55 per hour to be effective 1 November 1977. After discussion it was moved by Mrs. Bradley that this increase be approved, seconded by Mr. Neis, and carried unanimously.

Ms. Smith recommended an increase for Betty Schaumburg from her current rate of \$3.18 per hour to \$3.45 per hour commencing 1 November 1977. This increase is due to Ms. Schaumburg's enhancement in training and prospective change in position to head cook and food service director. After discussion it was moved by Mrs. Bradley that this increase be approved, seconded by Mr. Neis, and carried unanimously.

The Board discussed the formation of an advisory committee for the Valleyview Care Home. It was agreed by the Board that the following positions would exist on this advisory committee: A representative of (1) county commission, (2) the administrator of the home, (3) a RN, (4) a clergy, (5) a doctor from the community, and (6) the Valleyview residence council chairperson.
